JUMP currently has systems in the San Francisco Bay Area and Washington DC, and we have plans to expand to at least five major US cities in the next year. About the Role

We are currently seeking a Compliance and Fixed Asset Accountant to help manage and grow our electric bike share fleets. JUMP seeks professionals who are passionate about making cities better places to live and bike, care about customer service, and can help us continually improve our program's efficiency. As Compliance and Fixed Asset Accountant you will be responsible for coordinating, managing, and launching SoBi and JUMP systems. Working under the CFO and Financial Controller you will be expected to own the full fixed asset cycle from acquisition to disposal, as well as, assist in determining nexus, identifying filing requirements, and registering to ensure tax compliance in all states and local jurisdictions.

Responsibilities

- Fixed Assets
 - Location tracking and recording of cost for all fixed assets from acquisition to disposal.
 - Perform accounting for the disposition of fixed assets.
 - Calculate and record the depreciation for all fixed assets.
 - Monitor regular physical inventory counts of fixed assets.
 - Perform analysis related to fixed assets when requested by management.
 - Prepare master schedule for fixed assets.
 - Assist management with tracking expenditures of the company for fixed assets in comparison to capital budgets.
- Inventory
 - Assisting in the improvement in internal controls related to inventory
 - Monitoring inventory transactions
 - Reconciling inventory accounts to the general ledger
 - Preparing monthly journal entries as needed
 - Special projects as required
- Compliance:
 - Assist in determining nexus, identifying filing requirements and registering to ensure tax compliance in all state and local jurisdictions
 - Assist with preparing and filing required sales & use and other indirect tax returns, which includes preparing supporting documents and schedules and monitoring indirect tax calendar
 - Prepare and reconcile monthly estimates as needed to support indirect tax returns
 - Prepare journal entries and supporting schedules for tax accruals for quarterly and/or year-end close
 - Perform tax research and monitor tax rate and tax law changes
 - Oversee exemption certificate process
 - Assist with other projects within Tax department or across departments as needed
